- 8 Up to 90% of clinical waste and 35% of offensive waste produced in care homes is contaminated with recyclable materials
- If you're not waste compliant you could be paying £650-£850 per tonne
- Research shows that the average Care Home is losing £8,000 every year through poor waste management process and procurement









